

Residential Life Support Job Description

Job Requirements

- Must be at least 18 years of age.
- Must be physically and mentally capable of handling the care of campers.
- Must be familiar with and enforce all safety, emergency and camp policies.
- Serve as a role model and provide support to camp volunteers.
- Commit to fostering a community that celebrates our camp values, which are inclusion, gratitude, possibility, friendship and safety.
- Be flexible with the changing needs of the program areas and evening activities.
- The ability to work with a diverse community in a multicultural environment.
- Perform other duties as deemed necessary by camp leadership.
- Comply with and remain flexible with COVID-19 specific precautions and requirements throughout the program, as outlined/advised by the CDC and the Hole in the Wall Medical Team.
- All positions are residential and hired for the duration of our summer program. The time commitment is mid-June to mid-August.

Job Summary

The Residential Life Support position is a member of the Leadership Team and works closely with the Residential Life Coordinator to provide assistance to staff and volunteers for all camper and staff needs that arise. A main responsibility of this role is collaborating with staff to support camper behavioral needs each session. This position will also assist in facilitating staff and camper behavior trainings during orientation. The Residential Life Support will be able to demonstrate competency in behavioral development techniques and requires the ability to work both independently and as a part of a team. It also requires strong organizational, communication and teamwork skills. Prior leadership experience in a camp setting or equivalent is preferred.

Job Responsibilities:

Residential Life Responsibilities

• Work and communicate closely with the Residential Life Coordinator to determine how to best support each camper's unique needs, as well as the needs of the Camp program.

- Support summer staff and volunteers in their camper interactions and behavioral interventions.
- Serve as a resource for staff and volunteers and step in as a point person for counselors when the Residetial Life Coordinator is absent.
- Participate fully in summer leadership orientation.
- Check in with staff/volunteers frequently regarding camper needs and behavior.
- Provide direct therapeutic support and behavioral interventions to campers as needed.
- Prepare/distribute camper reports and relevant camper psychosocial information prior to each session.
- Oversee the completion of camper reports and behavioral information reports from each session.
- Assist with completing staff mid-summer and end of summer evaluations.
- Attend residential life meetings, both prior to and during each session. Facilitate meetings as needed.

Other responsibilities

- Assist in opening and closing day procedures.
- Present Camp rules at opening campfire and ensure Camp rules are followed.
- Help coordinate staff care and support programs as needed.
- Assist in planning/facilitation of staff orientation, particularly those portions related to camper behavior.
- Be willing to request help, advice and feedback from peers or support staff. It truly takes a village!
- Be responsible for knowing and adhering to policies and procedures contained in the Camp manual.
- Serve as a leader/role model for our Camp community.
- Attend all staff meetings and perform any other duties deemed necessary by the Camp Director and Assistant Camp Director.
